#### **C4C Updates**

- -C4C annual written report was completed last month and the next semi-annual in person EDC report will be on Nov. 16<sup>th</sup>. Our next quarterly written report will be due at the end of October.
- -Mayor reached out to leadership at the AFA to ensure process was going as expected for visitors center. Nothing new to report but second round of RFPs will be on hand in November.
- -UCCS is on track
- -No new news on sports stadium at this point but hopeful that Bob will be able to discuss something at state EDC meeting in November.
- -USOM just submitted requisition number 7 and it was approved last week.
- -S/W infrastructure component now has an updated letter from Mayor appointing Travis Easton and newly appointed CFO Charae McDaniel as the authorized signers for that req. process. The URA will also be working closely with Kathleen Krager and Ryan Phips as well. CP&Y is the authorized independent engineer.

#### **URA AREA UPDATES**

#### Gold Hill Mesa:

Set to present in November or December. Waiting on final confirmation.

#### City Aud:

A&A development is ready but wants to begin in Spring, city will participate in blight study waiting on Norwood piece to begin. A&A does have a meeting scheduled with Ryan Teferteller to begin their side of the work. Sam G. and Perry S. have expressed interest in doing a House of Blues concept in the city aud but more work in front of city and us to get there.

#### S. Nevada:

S. Nevada streetscape was formally approved by council earlier this month. Sam and Ray are here to today to discuss their bond numbers. Danny Mientka has a proposal he's putting together for corridor development but we will have to wait until next month to see what that looks like. Natural grocers set to open TOMORROW! Mad Greens is no longer coming in but Walt and Mark are quickly finding another tenant.

#### Polaris Point/Copper Ridge:

Submitted their second requisition for \$94,044 towards environmental assessments for the I-25 to Powers connection.

#### Vineyards:

GENERAL UPDATES: We MOVED. Today we are now in Suite 603

- 1) Had a great presentation to the parks board regarding URA functions. They were very happy with it and were particuliarly interested in city auditorium block. They also asked questions regarding low income housing and gentrification. Also had a great discussion and presentation to UCCS business class students who were interested in learning how business functions with the URA.
- 2) S/E Colorado Springs was featured on the Extra with Renee Roberts last week. Taj Stokes (who leads Thrive) became sick last minute and asked me to fill in the morning of. Went very well. Going to be working with the administration to push for any added incentives that can be given to a business that locates to the S/E side of town as opposed to anywhere else.
- 3) Jim DiBiase's updated study will be completed next week.
- 4) Field of dreams project may be seeking URA designation. Should have a presentation next month from them.
- 5) Hyperloop test track group has expressed interest in working with the URA and city leadership to help with where they want to do a track and what possibilities can be open to them. They've been talking with a lot of individuals around town but I want to make sure the board knows that we're involved.
- 6) Had some great calls with DCI over the last few weeks. One was with a lobbyist group representing Colorado Builds who is looking at a possible legislative concept in 2018 that would provide some additional flexibility within TIF for affordable housing (along with other infrastructure-oriented type of uses). Another call was discussing a district court in Wheat Ridge invalidating an anti-TIF initiative in Wheat Ridge. DCI has been an excellent partner and source for us.
- 7) Thank-you from downtown partnership for table sponsorship.
- 8) Budget ongoing moving to final draft.


#### S. Nevada:


#### **GENERAL UPDATES:**

#### District Court Invalidates Wheat Ridge Anti-TIF Initiative

On September 8, 2017, a Jefferson County District Court ("Court") essentially struck down Ballot Question 300 ("BQ300"), approved by the Wheat Ridge ("the City") voters on November 3, 2015.

The ballot question was an amendment to the City Charter which required that any agreement to share tax increment revenues must be ratified by the Wheat Ridge City Council at a regularly scheduled public hearing, and, if the amount exceeds \$2.5 million, must be ratified by Wheat Ridge voters.

A challenge to the initiative was brought in the form of a declaratory judgment action by the Long's Peak Metropolitan District ("District"), which is a party to a Cooperation Agreement with the Wheat Ridge Urban Renewal Authority ("Authority"). The Cooperation Agreement included a pledge by the Authority to the District of incremental tax revenues. The District alleged that the measure could have the effect of invalidating its existing Cooperation Agreement, as well as make it more difficult, time consuming and costly to negotiate an additional agreement, which it is actively seeking. Both parties filed Motions for Summary Judgment, on which the Court ruled on September 8, 2017.

The Court first addressed the question of standing, and found that the District did properly allege an injury-in-fact to a legally protected interest sufficient to demonstrate standing. The Court also found that the matter was sufficiently "ripe" for it to enter judgment.

Most notably, the Court found that the fundamental subject matter at issue, namely the remediation of urban blight, was a matter of mixed local and state concern. The Court went on to conclude that, because BQ300 required additional procedures for approval of tax increment financing ("TIF") that are not required by the statute, BQ300 was in conflict with state law, and therefore invalid – at least to the extent it required the additional procedures.

The City argued that BQ300 only addressed the issue of "internal financial controls of the City," which is a matter of strictly local concern, not urban blight and TIF arrangements. The Court disagreed, and noted that "local ordinances which require an additional layer of local government and/or voter approval with regard to TIF deposited into the urban renewal authority's special fund necessarily restrict (and potentially eliminate) that authority's access to the funds intended to combat slums and blight." The Court noted the risk of a ripple effect, in which developers, seeking a receptive community in which to invest, might relocate a planned project from one community to another, thus triggering additional restrictions.

Ultimately, the Court found a clear operational conflict between the requirements of BQ300 and the specific language in the Urban Renewal Law, C.R.S. 31-25-101 *et seq.*, which provides that urban renewal authorities have the power to enter into contracts, execute instruments, and take a broad variety of actions in furtherance of the goals of an urban renewal plan.

The Court allowed to stand the portion of BQ300 which required that an urban renewal plan be adopted in a public hearing before the City Council, because that requirement is consistent with a requirement that already exists in the Urban Renewal Law. And the Court stopped short of declaring that the entirety of BQ300 was valid and unenforceable.

Of note, a group of citizens in Arvada are currently collecting signatures on a petition to place a measure before Arvada voters that is very similar to BQ300. The Arvada measure includes the same requirement that both City Council and voters approve TIF Agreements of more than \$2.5 million, with the additional requirement that neither the City nor the Authority may sell or transfer property, the appraised value of which is more than \$1 million, unless ratified by City Council and a vote of the people.

It is unclear how the Court's recent decision will affect the Arvada measure. To the extent the Arvada measure is the same as BQ300, however, it is likely to be found similarly invalid.


